The confusion of darkness.

The governor of VA has been in the news in recent days, and for several reasons.

Governor Northam's first big exposure

The first "big" exposure was for his support for a piece of legislation called "The Repeal Act", which was introduced to the VA legislature by VA Delegate Kathy Tran. The Act is so named because it repeals all of VA's restrictions on abortion.
